**ASSIGNMENT OF TRADEMARKS, TRADEMARK APPLICATIONS

WITNESSETH:

WHEREAS, said Seller is the owner of the entire worldwide right, title and interest in and to the Trademarks and any registrations and applications therefore as listed in Schedule A;

WHEREAS, MUELLER HOLDINGS (N.A.), INC., formerly Hydrant Acquisition Corp., a Delaware corporation, having its principal place of business at c/o DLJ Merchant Banking, 277 Park Avenue, New York, New York 10172, hereinafter referred to as the "Buyer", through its wholly owned subsidiary, Mueller Group, Inc., a Delaware corporation ("Buyer Subsidiary"), is desirous of acquiring the entire worldwide right, title and interest in and to said Trademarks and any registrations and applications therefore.

ALL OF THE FOREGOING to be held and enjoyed by Buyer Subsidiary for its own use and for the use of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this transfer to Buyer Subsidiary had not been made.

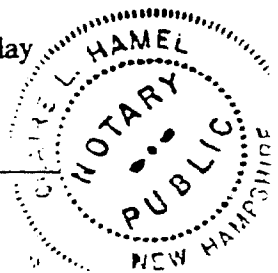
