**ASSIGNMENT OF INTENT-TO-USE TRADEMARK
AND APPLICATION THEREFOR**

WHEREAS, APTARGROUP, INC., a Delaware corporation, having its principal place of business at 475 West Terra Cotta Avenue, Crystal Lake, Illinois 60014 (hereinafter "Assignor"), has adopted and is using the mark SIMPLITWIST for which said assignor filed federal trademark registration application Serial No. 75/505,791, on September 25, 1995 in the U.S. Patent and Trademark Office, and owns all right, title and interest in and to the mark and trademark registration application;

FURTHER, Assignor agrees to execute and provide promptly after its execution hereof such further instruments and documents and assignments as may be reasonably necessary to effectuate the purpose of this Assignment and to enable Assignee to record in Assignee's name all of Assignor's rights in and to the mark with the Commissioner for Trademarks or any other appropriate governmental agency.

The Commissioner for Trademarks is requested to issue the certificate of registration to said Assignee.


