

**CERTIFICATE OF AMENDMENT OF
THE FOURTH AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
RANGESTAR INTERNATIONAL CORPORATION**

John Harris certifies that:

1. He is the duly elected and acting President of RANGESTAR INTERNATIONAL CORPORATION, a corporation organized and existing under the laws of the state of Delaware (the "Corporation").

2. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on February 13, 1996. The Fourth Amended and Restated Certificate of Incorporation of the Corporation (the "**Fourth Restated Certificate**") was filed with the Secretary of State of the State of Delaware on July 30, 1999 and amended on February 11, 2000.

3. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment of the Fourth Restated Certificate amends the provisions of the Fourth Restated Certificate.

4. The terms and provisions of this Certificate of Amendment of the Fourth Restated Certificate have been duly approved by written consent of the required number of shares of outstanding stock of the Corporation pursuant to Subsection 228(a) of the General Corporation Law of the State and written notice pursuant to Subsection 228(d) of the General Corporation Law of the State has been given to those stockholders whose written consent has not been obtained.

5. The First Article of the Fourth Restated Certificate of the Corporation is hereby amended to read in its entirety as follows:

ARTICLE ONE

"The name of this Corporation is Rangestar Wireless, Inc."

IN WITNESS WHEREOF, this Certificate of Amendment of Fourth Restated Certificate, which amends certain provisions of the Fourth Restated Certificate of the Corporation, having been duly adopted in accordance with Section 242 of the Delaware General Corporation Law, has been duly executed by its President, this 17 day of February, 2000.
