



# ASSIGNMENT

This Assignment is effective as of May 22, 2000.



The Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and such officials in foreign countries as are duly authorized by their laws to register the marks, to issue any and all certificates of registration for the marks to the Assignee as the owner of the entire interest, for the sole use and benefit of said Assignee, its successors, assigns and legal representatives.

Assignor agrees that, if for any reason this assignment is deemed ineffective, Assignor will again assign the Marks, separately or together, to Assignee upon registration of the Marks in the United States Patent and Trademark Office.


This Assignment shall be binding upon Assignor's successors and assigns. This Assignment may be executed simultaneously in multiple counterparts, each of which shall be deemed an original and each of which shall constitute one and the same instrument for purposes of evidencing this Assignment.

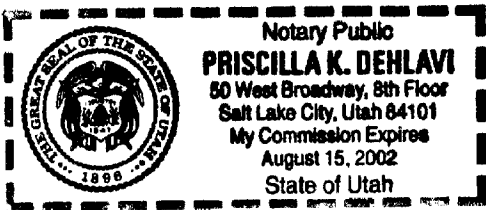
