

2. Assignor agrees, upon the request of Assignee, to execute any necessary and proper oaths or affidavits relating to said servicemark as required for the renewal, validation of use or status or extension that Assignee, which in the opinion of counsel for Assignee, may deem necessary or expedient.

3. Assignor agrees, upon the request of Assignee, in the event said servicemark becomes involved in a trademark controversy or cancellation, to cooperate to the best of its ability with Assignee in the matters of giving and producing evidence in support and by preparing and executing documents therefor, and further to perform, upon such request, any and all affirmative acts to obtain said servicemark and vest all rights therein hereby conveyed in the Assignee.

4. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all said servicemark registrations which are or may be granted, renewed or reissued, to the Assignee and hereby covenants that Assignor has full right to convey the entire interest herein assigned, and that

Assignor has not executed, and will not execute, any agreements in derogation thereof.

5. Assignee, by the execution of this Assignment, hereby accepts the aforesaid.

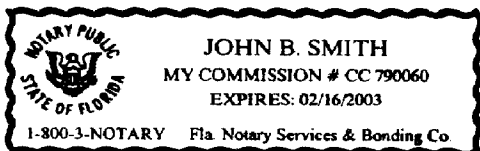
