*THIS ASSIGNMENT is made the 27<sup>th</sup> day of April 2000 in confirmation of an agreement dated 1<sup>st</sup> January 1998*

*BETWEEN*

*Capricorn Newell U.K. formerly known as McKechnie U.K., a private unlimited company No. 655,647, latterly of Wear Glass Works, Sunderland, Tyne & Wear, SR4 6EB ("the Assignor"), of the one part*

*Firetrace Systems Limited, formerly known as M & B Coachworks Limited, Company No. 460,496, of Inertia House, Lowther Road, Stanmore, Middlesex, HA7 1EP ("the Assignee"), of the other part*

*WHEREAS*

*A. The Assignor is the owner of the registered trade marks as identified in the Schedule appended hereto ("the Marks");*

*B. The Assignee is desirous of acquiring the rights in the Marks;*

*NOW THIS ASSIGNMENT WITNESSETH as follows:*

- 1. In consideration of the premises and for the sum of £500 (the receipt whereof is hereby acknowledged by the Assignor), the Assignor hereby assigns unto the Assignee, with full title guarantee to the Assignee, all that the property, right, title and interest in and to the Marks, in respect of all the goods for which they are registered, together with the whole of the goodwill of the business concerned in the goods, together also with all common law rights in the Marks and all accrued causes of action, to hold same unto the Assignee absolutely.*
  
- 2. The Assignor hereby warrants that it will not hereafter use the Marks in respect of parts of the said goods without the authority of the Assignee.*
  
- 3. It is hereby certified that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds £60,000.*
