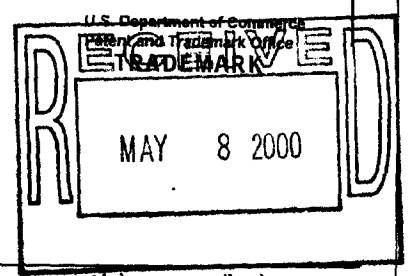

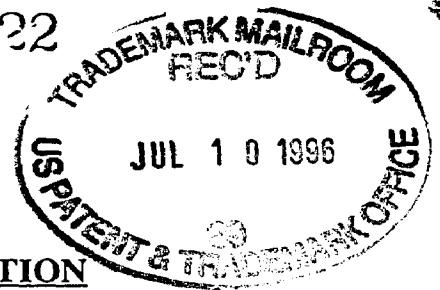

AMENDED ARTICLES OF INCORPORATION

OF

GUND BUSINESS ENTERPRISES, INC.  
(formerly Nationwide Advertising Service, Inc.)

- FIRST:** The name of the Corporation shall be GUND BUSINESS ENTERPRISES, INC.
- SECOND:** The principal office of the Corporation in the State of Ohio is to be located at Cleveland in Cuyahoga County.
- THIRD:** The purposes for which, and for any of which, the Corporation is formed are as follows:
1. To develop, produce, manufacture, buy, hold, sell and generally deal in products, goods, intangible assets and services of any and all kinds and to do all things necessary or incidental thereto.
  2. In general to engage in any lawful act or activities for which corporations may be formed under Sections 1701.01 to 1701.98, inclusive, of the Ohio Revised Code.
- FOURTH:** The number of shares which the Corporation is authorized to have outstanding is 2,500,000 shares of Common Stock without par value. Each share of Common Stock of the Corporation outstanding at the time of filing of these Amended Articles shall without more become and be changed into one thousand shares of Common Stock of the Corporation.
- FIFTH:** The Corporation may from time to time, pursuant to authorization by the Board of Directors and without action by the shareholders, purchase or otherwise acquire shares of the Corporation of any class or classes in such manner, upon such terms and in such amounts as the Board of Directors shall determine; subject, however, to such limitation or restriction, if any, as is contained in the express terms of any class of shares of the Corporation outstanding at the time of the purchase or acquisition in question.
- SIXTH:** These Amended Articles of Incorporation supersede and take the place of the existing Articles of Incorporation and all amendments thereto.
