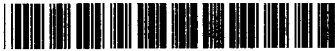


# MEMORANDUM OF SECURITY AGREEMENT - TRADEMARKS
