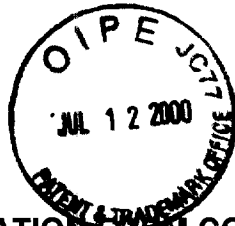

TRADEMARK ASSIGNMENT

ASSIGNMENT made this 4th day of July, 2000, by and between KABUSHIKI KAISHA NAKANOSUMISE, having an address of 2-6 Nakamura-cho, Handa-shi, Aichi-ken, Japan, a joint stock company of Japan, ("Seller"), and KABUSHIKI KAISHA MITSUKAN GROUP HONSHA, a joint stock company of Japan, having an address of 2-6 Nakamura-cho, Handa-shi, Aichi-ken, Japan ("Buyer"),

Seller further assigns to Buyer all rights to sue for and receive all damages occurring from past infringing uses of the Mark(s).

Seller warrants that it has good and valid title to the Mark(s), including the applications and registrations therefor. Seller agrees that upon request by Buyer, Seller shall execute all papers, make all rightful oaths, testify on behalf of Buyer and do all other lawful acts necessary to carry out the intent of this Assignment at Buyer's expense and request, as well as provide such other material, information, or assistance as Buyer may consider necessary.

This Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.
