NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS,  
SERVICE MARKS, PATENTS, COPYRIGHTS AND APPLICATIONS THEREFOR

This Notice of Release of Security Interests in Trademarks, Service Marks, Patents, Copyrights and Applications therefor is made as of June 30, 2000, by FLEET NATIONAL BANK, a national banking association organized under the laws of the United States of America, and having an office at One Federal Street, Mailstop: MA OF DO7A, Boston, Massachusetts 02110 (the "Bank") with reference to the following:


WHEREAS, on or about October 8, 1998, MULTEX.COM, INC., formerly known as Multex Systems, Inc. (the "Borrower") executed and delivered to the Agent its Security Agreement ("Original Security Agreement") granting the Bank security interests in certain collateral described therein for the pro rata benefit of the Lenders under that certain loan agreement as of even date therewith by and between the Borrower, the Bank and said Lenders ("Original Loan Agreement").

WHEREAS, pursuant to the terms of the Original Loan Agreement and the Original Security Agreement, and as an inducement to the Lenders agreeing to the acquisition by Borrower of MARKET GUIDE, INC. ("Market Guide"), Market Guide executed and delivered to Bank its Unlimited Guaranty (the "Market Guide Guaranty"), made as of October, 28, 1999, and that certain Security Agreement (the, "Market Guide Security Agreement"), made as of October 28, 1999, in favor of Bank. The Market Guide Security Agreement operated to grant Bank a security interest in certain trademarks, servicemarks, patents and copyrights of Market Guide. The Market Guide Security Agreement, accompanied by a Notice of Security Interest in Trademarks, Servicemarks, Patents, Copyrights and Applications Therefor, was subsequently recorded with the United States Patent and Trademark Office on November 24, 1999 in Reel 001993 at Frame 0311.

WHEREAS, on or about the date hereof, the Borrower, the Bank and the Lenders entered into that certain Amended and Restated Loan Agreement ("Amended Loan Agreement"). Pursuant to the terms of said Amended Loan Agreement, Bank will no longer hold a security interest in the trademarks, servicemarks, patents and copyrights of Market Guide.


