NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS,

This Notice of Release of Security Interests in Trademarks, Service Marks, Patents, Copyrights and Applications therefor is made as of July 28, 2000, by FLEET NATIONAL BANK, a national banking association organized under the laws of the United States of America, having an office at 111 Westminster Street, Providence, Rhode Island 02903 ("Fleet") with reference to the following:

WHEREAS, in connection with various financing arrangements with Fleet, THE NAPIER CO.
