TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of this 30th day of May, 2000 ("Effective Date"), by and between Chevron Corporation, a Delaware corporation ("Assignor"), and Petrocosm Corporation, a Delaware corporation ("Assignee").




