**ASSIGNMENT AND ACCEPTANCE OF
TRADEMARK CONSENT AGREEMENT**

This AGREEMENT is made as of the June 22, 2000, between E. I. DU PONT DE NEMOURS AND COMPANY, a Delaware corporation (hereinafter referred to as "DuPont") and AMVAC CHEMICAL CORPORATION, A California corporation (hereinafter referred to as "AMVAC").

WITNESSETH:

1. For good and valuable consideration paid by AMVAC to DuPont, the receipt of which is hereby acknowledged, DuPont, for itself and its successors and assigns, does hereby assign, transfer, and set over unto AMVAC, its successors and assigns, all of DuPont's rights, title and interest with respect to FORTRESS® Trademark Consent Agreement dated March 10, 1998 between DuPont and Pfizer, Inc.
2. AMVAC for itself and its successors and assigns, does hereby accept, take over, and succeed to all DuPont's right, title, and interest in and to said agreement accruing from the date of the Assignment forward, and does hereby covenant with DuPont and its successors and assigns, to fully and faithfully make, keep, perform and assume all payments, terms, conditions, provisions, covenants, and obligations contained in said agreements, to be made, kept, or performed by their respective terms accruing from the effective date of the Assignment forward.
3. This Assignment and Acceptance is made subject to and in accordance with the terms and conditions of the Purchase and Sale Agreement dated January 20, 2000, by and between DuPont and AMVAC.
4. The effective date of this Assignment is midnight on the evening of June 22, 2000.
