
FIRST: The name of this corporation shall be:

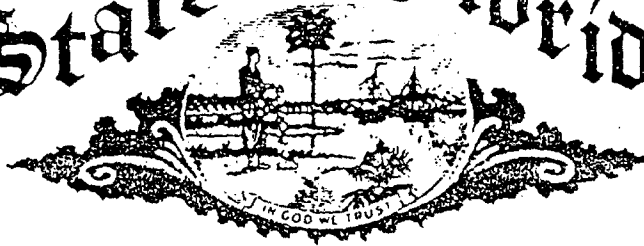

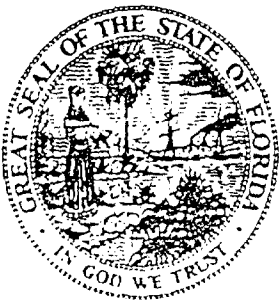
