WHEREAS, Assignor is also the owner of the pending trademark and service mark use applications set forth in Exhibit 2 and incorporated herein by reference;


WHEREAS, Assignor is also the owner of the pending trademark and service mark intent-to-use applications set forth in Exhibit 3 and incorporated herein by reference;
