

OF THE STATE OF IOWA:

Pursuant to Section 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts the following amendment to the corporation's Articles of Incorporation:

1. The name of the Corporation is Economy Forms Corporation.
2. Article 1 of the Articles of Incorporation is hereby amended in its entirety to read as follows:

ARTICLE 1

NAME

The name of the corporaiton is EFCO Corp. (the "Corporation").

3. The date of adoption of the amendment was May 19, 1995.
4. The amendment was approved by the shareholders. The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the amendment and the number of votes of each voting group indisputably represented at the meeting are as follows:
