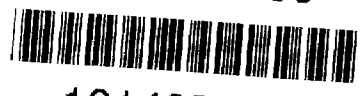

FULL RELEASE OF SECURITY INTEREST

WHEREAS, Buzzeo, Inc., a corporation organized and existing under the laws of Arizona and having a principal place of business at 4041 North Central Avenue, Suite 150, Phoenix, Arizona 85012 (hereinafter "RELEASEE"), and Imperial Bank, a California banking corporation, with a principal place of business at 9920 South La Cienega Blvd., Suite 636, Englewood, CA 90301 (hereinafter "RELEASOR"), entered into a Loan Agreement, dated May 2, 1997, as modified, evidencing certain loans (collectively, the "LOANS"); and
