

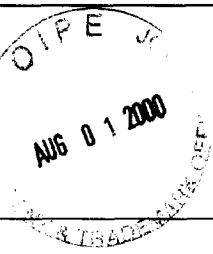

ASSIGNMENT OF TRADEMARKS (FEDERAL)

This Assignment of Trademarks ("Assignment") is made as of June 26, 2000 by The Chronicle Publishing Company, a Nevada corporation ("Seller"), having its principal place of business at 901 Mission Street, San Francisco, California 94103, to Young Broadcasting of San Francisco, Inc., a Delaware corporation ("Purchaser"), having its principal place of business at 599 Lexington Avenue, New York, New York 10022.

RECITALS

1. Young Broadcasting Inc., a Delaware corporation, and Seller have entered into an Asset Purchase Agreement, dated as of November 15, 1999 (the "Purchase Agreement"), which provides, among other things, for the acquisition by Purchaser of certain assets of Seller.
2. Seller is the exclusive owner of all of the right, title and interest in and to the trademarks listed on Exhibit A hereto (the "Marks").
3. Seller desires to transfer and assign to Purchaser all of its rights, title and interest in and to the Marks, and the business goodwill symbolized thereby.

AGREEMENT

NOW, THEREFORE, for the consideration specified in the Purchase Agreement, and other good and valuable consideration, the receipt of which is hereby acknowledged, Seller does hereby grant, bargain, sell and assign to Purchaser all right, title to, and interest in the Marks, and the goodwill of the business symbolized thereby, together with all claims for profits, damages and equitable relief by reason of past infringement of the Marks by any party or parties.

For the consideration set forth above, Seller for itself, its successors and assigns hereby covenants and agrees that, at any time and from time to time forthwith upon the written request of Purchaser, Seller will do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered, each and all of such further acts, deeds, assignments, transfers, conveyances, powers of attorney and assurances as may reasonably be required by Purchaser in order to assign, transfer, set over, convey, assure and confirm unto and vest in Purchaser, its successors and assigns, title to the Marks.



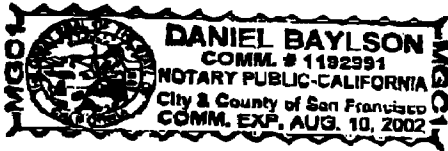

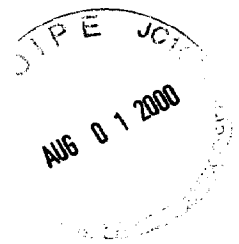
