RELEASE OF ASSIGNMENT OF TRADEMARKS AND PATENTS

This Release, effective as of July 21, 2000, is executed pursuant to certain Credit Facility Agreements executed in 1991, 1989 & 1986 between the Forum Corporation of North America, a Delaware corporation (the "Company") and State Street Bank and Trust Company, a Massachusetts trust company (the "Bank").

1. Pursuant to the aforementioned 1991 Credit Facility Agreement, the Company executed an Assignment of Trademarks and Patents recorded on June 19, 1991 in the records of the U.S. Patent and Trademark Office in Washington D.C. on Reel 0796, Frame 0143 ("1991 Trademark Mortgage").

2. Pursuant to the aforementioned 1989 Credit Facility Agreement, the Company executed an Assignment of Trademarks and Patents recorded on March 3, 1989 in the records of the U.S. Patent and Trademark Office in Washington D.C. on Reel 0640, Frame 0804 ("1989 Trademark Mortgage").

3. Pursuant to the aforementioned 1986 Credit Facility Agreement, the Company executed an Assignment of Trademarks and Patents recorded on May 16, 1986 in the records of the U.S. Patent and Trademark Office in Washington D.C. on Reel 0529, Frame 0316 ("1986 Trademark Mortgage").

4. Pursuant to the terms of the 1991, 1989 & 1986 Trademark Mortgages, which have all been subsequently terminated and all obligations of the Company there under satisfied, the Company has requested that the Bank release and terminate any and all of the Bank's security interest in the following trademarks (the "Unreleased Trademarks"), which the Bank acquired as collateral pursuant to the mortgages:
