

ASSIGNMENT AND ASSUMPTION OF TRADEMARKS AND NAMES

THIS ASSIGNMENT AND ASSUMPTION OF TRADEMARKS AND NAMES, dated this 4th day of May, 1999 by and between COZZOLI'S PIZZA SYSTEMS, INC., a Florida corporation ("Assignor"), and COZZOLI'S PIZZA HOLDING, L.L.C., a Delaware limited liability company ("Assignee").

WHEREAS, Assignor and Assignee entered into that certain Agreement for Sale and Purchase of Assets dated October 15, 1998 and all amendments and riders thereto (the "Agreement"), for the sale and purchase of certain Assets (as such terms are defined in the Agreement);

WHEREAS, Assignor desires to assign, transfer, set over and deliver to Assignee all of Assignor's right, title and interest in and to certain trademarks and names as hereinafter provided; and

WHEREAS, Assignee desires to assume the duties and obligations of Assignor with respect to such trademarks and names.

NOW, THEREFORE, in accordance with the Agreement and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties do hereby covenant and agree as follows and take the following actions:

1. Assignment. Assignor does hereby assign, transfer, set over and deliver unto Assignee all of the Assignor's right, title and interest, if any, in and to all of Assignor's trademarks, trade names, logos, copyrights and patents (collectively, the "Names"), including, but not limited to:

(a) those certain marks registered in the Patent and Trademark Office of the United States of America, under (i) registration No. 1,048,738, issued September 21, 1976 (Cozzoli and Des.), (ii) Registration No. 1,116,492, issued April 10, 1979 (Cozzoli's), (iii) registration No. 1,145,334, issued December 30, 1980 (For the Slice of Your Life), (iv) any rights with respect to the foregoing marks as a result of that certain filing with the Registry of Industrial Property of Costa Rica on February 15, 1994; and (v) any rights with respect to the foregoing marks as a result of filings in Peru and Cairo; and

(b) the following names (i) Hop Too's, (ii) Cozzoli's Pizza, (iii) Cozzoli's Pizzeria; (iv) Cozzoli's Pizza Cafe; and (v) all names listed on Exhibit "A" attached hereto.

2. Assumption. Assignee hereby accepts the foregoing assignment of the Names and hereby assumes all duties and obligations of Assignor under the Names assigned herein. Assignee acknowledges and agrees that the Assignor makes no representation or warranty regarding the status of the mark referenced in 1(a)(i), above, or Assignor's ownership thereof.


