RELEASE AND REASSIGNMENT OF TRADEMARK

WHEREAS, the Company has paid and performed in full its obligations to the Bank and terminated all further obligations of the Bank to extend credit to the Company and its affiliates;



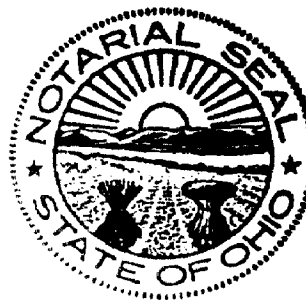
