RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, pursuant to an Intellectual Property Security Agreement recorded in the United States Patent and Trademark Office on February 19, 1998 at Reel 1696, Frame 0422 (the "Security Agreement"), DYAD MORTGAGE TECHNOLOGIES, INC., a Georgia corporation (the "Debtor") assigned to SIRROM INVESTMENTS, INC., a Tennessee corporation (the "Lender"), and granted to the Lender a continuing security interest in, the trademark described on Attachment A (the "Intellectual Property");

WHEREAS, the collateral assignment and grant to the Lender of the security interest in the Intellectual Property pursuant to the Security Agreement secured the payment of the Obligations (as defined in the Security Agreement); and

The Lender hereby represents to the Debtor that the Lender has not assigned its interest in the Intellectual Property and that the Lender has all due authority to enter into this Agreement and perform its terms.

This instrument shall be binding upon the Lender and its successors and assigns, and shall inure to the benefit of the Debtor and its successors and assigns.

This instrument shall be effective as of the close of business on September 3, 1999.
