

SUNDAY HOUSE FOODS, INC., a Texas Corporation

Pursuant to the provisions of the Texas Business Corporation Act, the undersigned corporations adopt the following Articles of Merger for the purpose of merging the corporations into one corporation:

- The name and state of incorporation of each corporation that is a party to the plan of 1. merger are:
 - Sunday House Foods, Inc., a Texas corporation ("Sunday House"); and (a)
 - **(b)** Willow Brook Foods, Inc., a Missouri corporation ("Willow Brook").
- An Agreement and Plan of Merger (the 'Plan of Merger') has been approved by the shareholders and board of directors of each of Sunday House and Willow Brook.
- No amendment to the Articles of Incorporation of Willow Brook, the surviving 3. corporation, is desired to be effected by the merger.
- 4. An executed Plan of Merger is on file at the principal place of business of Willow Brook at 405 North Jefferson Avenue, Springfield, Greene County, Missouri 65805.


