

TERMINATION STATEMENT FOR INTELLECTUAL PROPERTY SECURITY AGREEMENT

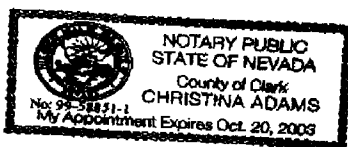
