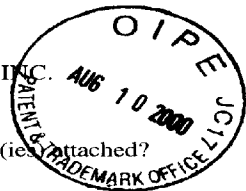

**PELMOREX COMMUNICATIONS INC.****CONDITIONAL ASSIGNMENT OF TRADE-MARKS**

WHEREAS Pelmorex Communications Inc. (the "Debtor"), whose address is 1 Robert Speck Parkway, Suite 1600, Mississauga, Ontario, L4Z 4B3, owns the trade-marks described on Exhibit A annexed hereto (the "Trade-marks");

AND WHEREAS Debtor has granted a general security agreement dated as of July 26, 2000, and other security (as amended or otherwise modified from time to time, collectively, the "Security") in favour of The Toronto-Dominion Bank in its capacity as agent (the "Agent") under a credit agreement (the "Credit Agreement") dated as of July 26, 2000 among, *inter alia*, the Debtor, the Agent and the Lenders as continuing security for the Obligations, as defined in Guarantee made as of July 26, 2000 by the Debtor in favour of the Agent;

AND WHEREAS, pursuant to the Security, the Debtor has granted to the Agent on behalf of the Lenders a security interest in, and mortgage on, all right, title and interest of Debtor in and to all intangibles of Debtor, which intangibles are intended to include the Trade-marks including all applications and registrations therefor in the Canadian Intellectual Property Office and including, without limitation, any claims by Debtor against third parties for infringement thereof (the "Collateral"), in order to secure the prompt payment, performance and observance of the Obligations;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Debtor does hereby grant to the Agent on behalf of the Lenders a specific security interest in the Collateral and, contingent upon the occurrence of an Event of Default (as defined in the Credit Agreement) and the Lenders having determined to enforce the security hereby constituted, the Debtor hereby assigns the Collateral to the Agent, in order to secure the prompt payment, performance and observance of the Obligations.
2. Debtor and the Agent hereby agree that the assignment referred to in Section 1 and the assignment and mortgage referred to in the Security, as it relates to the Trade-marks only, is conditional upon, and shall not be effective until, the occurrence of an Event of Default (as defined in the Credit Agreement) and during the continuance thereof. After the occurrence and during the continuance of an Event of Default, the Agent hereby grants Debtor an exclusive, royalty-free license to use the Trade-marks until the earlier of:
  - (a) the sale or transfer by or on behalf of the Agent of the Trade-marks to a third party; or

(b) notice from the Agent to Debtor that such license is terminated.



4. In the event of any conflict or inconsistency between the terms of this Agreement and the terms of the Credit Agreement, the terms of the Credit Agreement shall prevail.
