

**CERTIFICATE OF OWNERSHIP AND MERGER
 MERGING
 THE NATIONAL ACME COMPANY
 AND NATIONAL ACME TRADING COMPANY
 INTO
 DEVLIEG-BULLARD, INC.**

(PURSUANT TO SECTION 253 OF THE GENERAL CORPORATION LAW OF DELAWARE)

DeVlieg-Bullard, Inc., a corporation incorporated pursuant to the provisions of the General Corporation Law of the State of Delaware (the "Company"), does hereby certify that it owns all of the capital stock of The National Acme Company, a corporation incorporated under the laws of the State of Ohio ("ACME"), and National Acme Trading Company, a corporation incorporated under the laws of the State of Ohio ("NATCO"), and that the Company, by a resolution of its Board of Directors duly adopted at a meeting held on the 17th day of October 1995, determined to (i) merge into itself said ACME and NATCO and assume all their respective obligations (the "Merger"), (ii) make and execute an Agreement and Plan of Merger with respect to said Merger and (iii) file this Certificate of Ownership and Merger in the office of the Secretary of State of the State of Delaware and the Office of the Recorder of Deeds. The Board of Directors, in the following words, specifically resolved to wit:

WHEREAS, the Company now owns all of the outstanding capital stock of ACME and NATCO; and

WHEREAS, it is deemed advisable that the Company merge with ACME and NATCO in order that all the estate, property, rights, privileges, and franchises of ACME and NATCO, shall vest in and be possessed by the Company.

NOW, THEREFORE, BE IT RESOLVED, that ACME and NATCO be merged with and into the Company, and that the Company assumes all their respective obligations;

FURTHER RESOLVED, that the proper officers of the Company, and each of them, are hereby authorized and directed to make and execute, in the name of the Company, the Agreement and Plan of Merger as presented to the Board of Directors; and

FURTHER RESOLVED, that the proper officers of the Company, and each of them, are hereby authorized and directed to file a Certificate of Ownership and Merger in the Office of the Secretary of State of the State of Delaware and to do all other acts and things that may be necessary to carry out and effectuate the purpose of these resolutions.
