

ASSIGNMENT OF TRADEMARKS

This Assignment is given pursuant to the Purchase Agreement and is subject to the terms thereof and shall not be construed to modify, limit, alter, impair, enhance or enlarge the rights and obligations of Assignee and Assignor under the Purchase Agreement and is given solely for purposes of separately evidencing the transactions contemplated thereby.


