

WHEREAS, RB of Memphis, Inc., a Tennessee corporation having a principal place of business at 2300 Sitler, Memphis, County of Shelby, Tennessee 38114 (hereinafter, "RB"), is desirous of acquiring from McAuley's the entire right, title and interest in and to said Marks and the goodwill of the business associated therewith and said Trademark Applications and Registrations therefor;

WHEREAS, pursuant to the terms and conditions of an Order Confirming Debtor's Revised Amended Plan of Reorganization or Liquidation (the "Plan") as filed October 5, 1999, in Case No. 99-21267 JDL of the United States Bankruptcy Court for the Western District of Tennessee (Western Division), and further pursuant to an Asset Purchase Agreement (the "Asset Purchase Agreement") entered into and effective as of October 15, 1999, by and between said McAuley's and said RB, McAuley's did agree to sell certain of its assets to RB, including that portion of McAuley's ongoing and existing business to which said Marks pertain;

NOW, THEREFORE, in consideration of the terms and conditions of the Plan, and subject only to the terms and conditions of the Plan, and in furtherance of the Plan and the Asset Purchase Agreement, McAuley's ("Assignor"), by these presents does sell, assign and transfer unto the said RB ("Assignee"), *nunc pro tunc* effective as of October 15, 1999, Assignor's full and exclusive right, both in the United States and throughout all countries foreign to the United States, in and to the said Marks, the goodwill of the business associated therewith, and the said Trademark Applications and Registrations therefor, forever.


McAuley's (Assignor) covenants that no assignment, sale agreement or encumbrance has been or will be made or entered into that would conflict with this assignment other than as disclosed in said Plan and/or said Asset Purchase Agreement. Applications and Registrations therefor as may be known and accessible to Assignor and (ii) Assignor will cooperate with Assignee in providing testimony as to said Trademark Applications and Registrations in litigation or proceedings related thereto and will use its best efforts to promptly execute and deliver to Assignee or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, register and enforce said Trademark Applications and Registrations.


