

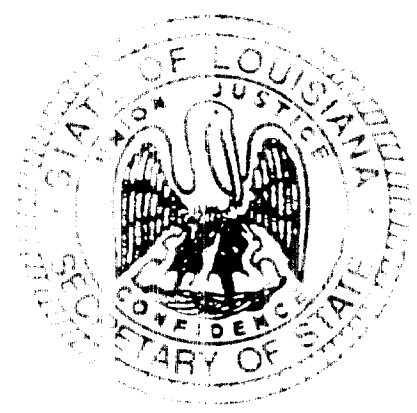

The Articles of Incorporation of the Corporation were amended by said resolution as follows:




