
WHEREAS, the Trademark is the subject of U.S Registration No. 1,732,368; and

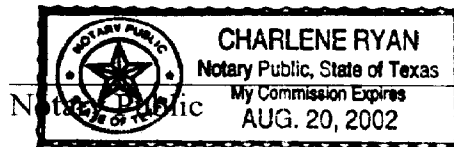
