

## SERVICES AND LICENSE AGREEMENT


AGREEMENT dated as of August 7, 2000 between PCi Services, Inc. – DE, a Delaware Corporation with its address at 30 Winter Street, Boston, MA 02108 (“PCiS DE”), PCi Services, Inc., a Massachusetts Corporation, with its address at 30 Winter Street, Boston, MA 02108 (together with PCiS DE, “PCiS”) and PCi Commercial, Inc., a Delaware Corporation, with its address at 30 Winter Street, Boston, MA 02108 (“PCiC”).

NOW THEREFORE, in consideration of the mutual agreements hereinafter set forth, the parties hereto agree as follows:

IN WITNESS WHEREOF, the undersigned have executed, or have caused this Agreement to be duly executed by their respective authorized officers, as of the day and year first above written.


