SECOND AMENDMENT OF SECURITY AGREEMENT

AMENDMENT OF SECURITY AGREEMENT dated as of May 12, 2000, by and between **SUNLIGHT FOODS, INC.**, a California corporation ("Grantor"), and **U.S. BANK NATIONAL ASSOCIATION**, a national banking association ("Lender").

W I T N E S S E T H :

A. Pursuant to a security agreement dated August 2, 1999 as amended on February 10, 2000 (the "Security Agreement"), Grantor granted to Lender a security interest in certain collateral described therein to secure all indebtedness under a certain credit agreement between Maranatha Holding Corp., a Delaware corporation ("Borrower"), and Lender dated August 2, 1999, in a principal amount of \$4,250,000.

B. Pursuant to a first amendment and restatement of said credit agreement dated February 10, 2000, the indebtedness secured by the Security Agreement was increased by \$1,500,000.

C. Pursuant to a second amendment and restatement of said credit agreement, Lender has loaned or agreed to loan to Borrower the additional sum of \$5,750,000.

D. Grantor is a wholly-owned subsidiary of Borrower and will benefit directly and indirectly from the loan to Borrower.

E. As a condition precedent to making the loan to Borrower, Lender has required that Grantor amend the Security Agreement such that it secures the additional indebtedness.

NOW, THEREFORE, the parties agree as follows:

1. All of the assets acquired by Grantor pursuant to the asset purchase agreement between Grantor and Cloud Nine, Inc., dated as of May 12, 2000, including without limitation the items listed on Schedules 2.1(b) through 2.1(l) attached hereto, shall secure the Indebtedness (as that term is defined in the Security Agreement) and are hereby added to the definition of "Collateral" contained in Section 1.2 of the Security Agreement.

2. Section 1.3 of the Security Agreement is hereby amended and restated to read in its entirety as follows:

"The words 'Credit Agreement' means the Second Amended and Restated Credit Agreement between Borrower, Guarantor, Maranatha Acquisition Corp., and Lender dated as of May 12, 2000, together with all amendments and restatements thereof, renewals of, extensions of, modifications of, refinancings of, consolidations of and substitutions for the Credit Agreement, including all increases of Indebtedness under the Credit Agreement."

3. Schedule 2 attached to this Amendment is substituted for Schedule 2 attached to the Security Agreement.

4. Except as expressly set forth herein, the Security Agreement shall remain unmodified and in full force and effect.
