WHEREAS Hunting World Inc., is the owner of the trademarks shown in Exhibit A, and


WHEREAS the Robert M. Lee Trust is desirous of acquiring said trademarks in Exhibit A.

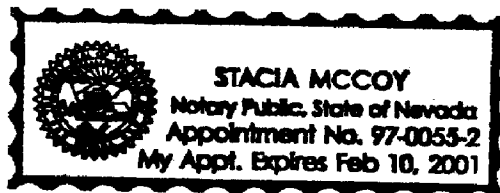
