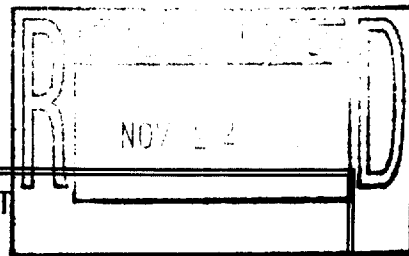

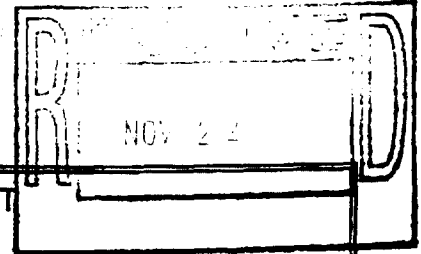

ASSIGNMENT
