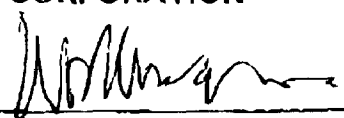
**FURTHER RESOLVED:** that this merger shall become effective at the close of business on December 31, 1999; and

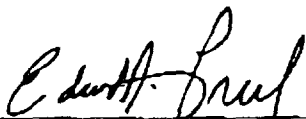
