RELEASE OF SECURITY INTEREST

Should the Grantor so desire, Lender shall execute a UCC-3 Financing Statement Change and other such documents as may be appropriate releasing the collateral described above.


This Release should be governed by and construed in accordance with the laws of the State of Florida.


