RELEASE OF SECURITY INTEREST

BE IT KNOWN that the undersigned, **SUNTRUST BANK, SOUTH FLORIDA, NATIONAL ASSOCIATION**, a national banking association with its principal banking office located at 515 East Las Olas Boulevard, Fort Lauderdale, Broward County, Florida (the "Grantee") for its benefit as the Grantee of a first priority security interest in the Trademark License Agreement dated January 1, 1997 between Grantor and Sea and Ski Delaware, Inc., pursuant to a certain Grant of Security Interest (Trademark License) dated November 13, 1997 and recorded at the United States Patent and Trademark Office on March 26, 1998 at REEL 1710, FRAME 0182 (the "Security Agreement") and the presently record holder of a security interest granted by **SEA & SKI CORPORATION**, a Florida corporation, with its principal office located at 8180 N.W. 36th Street, Suite 105, Miami, Florida (the "Grantor") pursuant to the Security Agreement for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby fully, completely and without reservation of any kind, discharge, release and relinquish the Grantor, its successors and assigns, for the security interest held by Grantee insofar as it related to all of Grantee's right, title and interest in and to the trademark applications or registrations listed on the attached Schedule A together with the goodwill associated with the trademarks.

Should the Grantor so desire, Grantee shall execute a UCC-3 Financing Statement Change and other such documents as may be appropriate releasing the collateral described above.


This Release should be governed by and construed in accordance with the laws of the State of Florida.

Any amendment or modification of this Release must be made in a separate writing by Grantee.




