

WHEREAS, Sierra Expeditions Ltd. is desirous of acquiring said trademarks in Exhibit A.





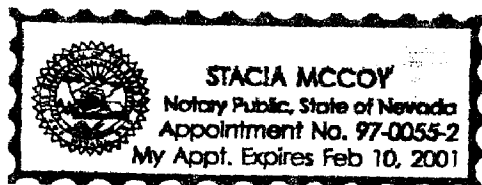
