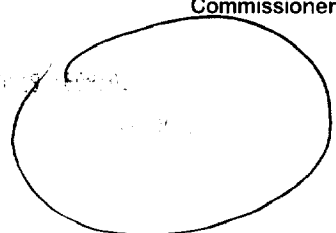

**AGREED ORDER**

It appearing to the Court, based upon the representations of counsel for the trustee and the President of Marbleine, Inc., as evidenced by their signatures appended to this Agreed Order, that

1. The debtor, Western Reserve Products, Inc., prior to the filing of the petition seeking protection under the Bankruptcy Act in this case, was the owner of U.S. Trademark Registration No. 1,609,103 for the mark Marbleine, and further
2. More that ninety days prior to the filing of a petition seeking protection under the Bankruptcy Act in this case that the debtor had transferred all of the business associated with the Marbleine trademark and the Marbleine trademark registration itself to Marbleine, Inc for good and valuable consideration; and
3. At the time of the filing of petition seeking protection under the Bankruptcy Act in this case, the debtor had no interest in the U.S. Trademark Registration No. 1,609,103, but the debtor had failed to execute an assignment transferring said registration to Marbleine, Inc.
