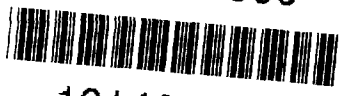



FIRST: That the Board of Directors, by unanimous written consent, duly adopted a resolution setting forth a proposed amendment of the Certificate of Incorporation of said corporation, and declaring said amendment to be advisable. The resolution setting forth the proposed amendment is as follows:
