## CERTIFICATE OF AMENDMENT TO AMENDED AND RESTATED

CERTIFICATE OF INCORPORATION

COAXICOM, INC.

(PURSUANT TO SECTION 242)

The undersigned, Vern M. Kennedy, being the President of COAXICOM, INC., a Delaware corporation (the "Corporation"), hereby certifies:

- 1. The name of the Corporation is Coaxicom, Inc. The Corporation's Certificate of Incorporation was originally filed with the Secretary of State of the State of Delaware on November 19, 1996, and was amended and restated as of September 10, 1998 and April 23, 1999, respectively (the "Amended and Restated Certificate of Incorporation").
- 2. The Amended and Restated Certificate of Incorporation is hereby amended by deleting <u>ARTICLE ONE</u> in its entirety and replacing it with the following:

## **ARTICLE ONE**

The name of the Corporation is Broadview Networks Holdings, Inc. (the "Corporation").

3. The Amended and Restated Certificate of Incorporation is hereby further amended by deleting the words and symbols "Two Million Nine Hundred Thousand (2,900,000)" and substituting "Four Million One Hundred Thousand (4,100,000)" in their place where they appear in paragraph 5.3.10 of Section (C) and paragraph 5.7 of Section (D) of ARTICLE FOUR.
