

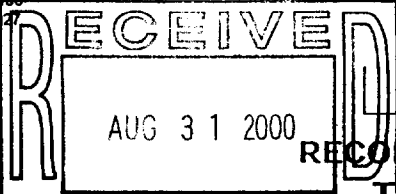

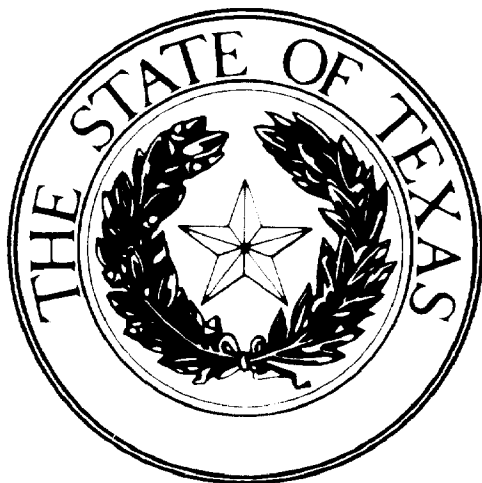

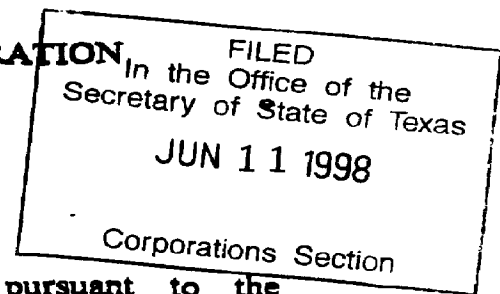

AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

FARAH INCORPORATED



1. FARAH INCORPORATED (the "Corporation"), pursuant to the provisions of Article 4.07 of the Texas Business Corporation Act, hereby adopts amended and restated articles of incorporation which accurately copy the articles of incorporation and all amendments thereto that are in effect to date and as further amended by such restated articles of incorporation as hereinafter set forth and which contain no other change in any provision thereof.

2. The articles of incorporation of the Corporation are amended by the restated articles of incorporation by deleting in their entirety Articles One and Four and inserting new Articles One and Four as follows:

ARTICLE ONE

The name of the corporation is Savane International Corp.

ARTICLE FOUR

The total number of shares of stock which the Corporation shall have authority to issue is one thousand (1000) shares, all of which shall be common stock (par value \$.01 per share).

3. There was no exchange, reclassification or cancellation of issued shares of common stock of the Corporation as a result of the change in the par value of the shares of common stock of the Corporation from no par value to \$.01 par value per share.

4. The articles of incorporation prior to this amendment stated that the Corporation's registered office was 8889 Gateway West, El Paso, Texas, and that the name of the registered agent at such address was William F. Farah. However, pursuant to a filing with the Secretary of State of Texas, the registered office of the Corporation was

changed to 6070 Gateway East, Building E, Suite 102, El Paso, Texas 79905, and the registered agent was changed to Crawford Kerr, Jr.

5. Each such amendment made by these restated articles of incorporation has been effected in conformity with the provisions of the Texas Business Corporation Act and such restated articles of incorporation and each such amendment made by the restated articles of incorporation were duly adopted by the shareholders of the Corporation on the 10th day of June, 1998.

6. The number of shares outstanding was 100; the number of shares entitled to vote on the restated articles of incorporation as so amended was 100; the number of shares voted for such restated articles of incorporation as so amended was 100; and the number of shares voted against such restated articles of incorporation as so amended was zero (0).

7. The articles of incorporation and all amendments and supplements thereto are hereby superseded by the following restated articles of incorporation which accurately copy the entire text thereof as further amended as above set forth, and no other provision is changed except as set forth above:

ARTICLE ONE

The name of the Corporation is Savane International Corp.

ARTICLE TWO

The period of the Corporation's duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the Corporation is organized are: To engage in any commercial, mercantile, industrial, manufacturing, merchandising, transportation, marine, exploration, mining, agricultural, research, licensing, servicing or agency business not prohibited by law, and any, some or all of the foregoing. The Corporation will not commence business until it has received for the issuance of its shares consideration of the value of not less than One Thousand Dollars (\$1,000).

ARTICLE FOUR

The total number of shares of stock which the Corporation shall have authority to issue is one thousand (1,000) shares, all of which shall be common stock (par value \$.01 per share).

ARTICLE FIVE

The post-office address of the Corporation's registered office is 6070 Gateway East, Building E, Suite 102, El Paso, Texas 79905, and the name of its registered agent at such address is Crawford Kerr, Jr.

ARTICLE SIX

The number of directors of the Corporation may be fixed by the by-laws, but shall not be less than three (3).

ARTICLE SEVEN

ARTICLE EIGHT

The shareholders of the Corporation shall not be entitled to any preemptive right to acquire unissued or treasury shares of the Corporation.

ARTICLE NINE

Each outstanding share of common stock shall be entitled to one vote on all matters submitted to a vote at a meeting of shareholders. The shareholders of the corporation shall not be entitled to the right of cumulative voting.

ARTICLE TEN

A director of the Corporation shall not be liable to the Corporation or its shareholders for monetary damages for an act or omission in the director's capacity as a director, except to the extent such exemption from liability or limitation thereof is not permitted under the Texas Miscellaneous Corporation Laws Act as currently in effect or as the same may hereafter be amended.

No amendment, modification or repeal of this Article Ten shall adversely affect any right or protection of a director that exists at the time of such amendment, modification or repeal.
