TRADEMARK ASSIGNMENT



CerMex agrees to execute and deliver at the request of Cabo all papers, instruments, and assignments, and to perform any other reasonable acts Cabo may request in order to vest in Cabo all of CerMex’s right, title, and interest in and to the Marks and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Cabo, to the extent such evidence is in the possession or control of CerMex.

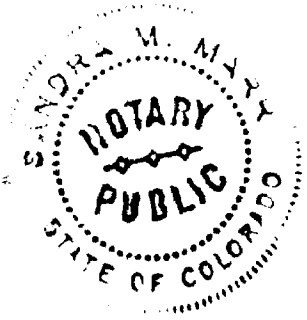
