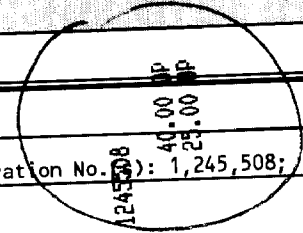



for past infringement of the said marks.


