



Carry-Lite does hereby covenant and agree with PRADCO to execute and deliver such other and further instruments and to take such other and further actions as may be reasonably necessary or appropriate to transfer said tradenames and trademarks, claims for damages by reason of past infringement and right to sue and collect therefor to PRADCO.




