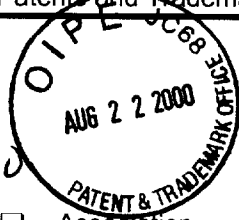

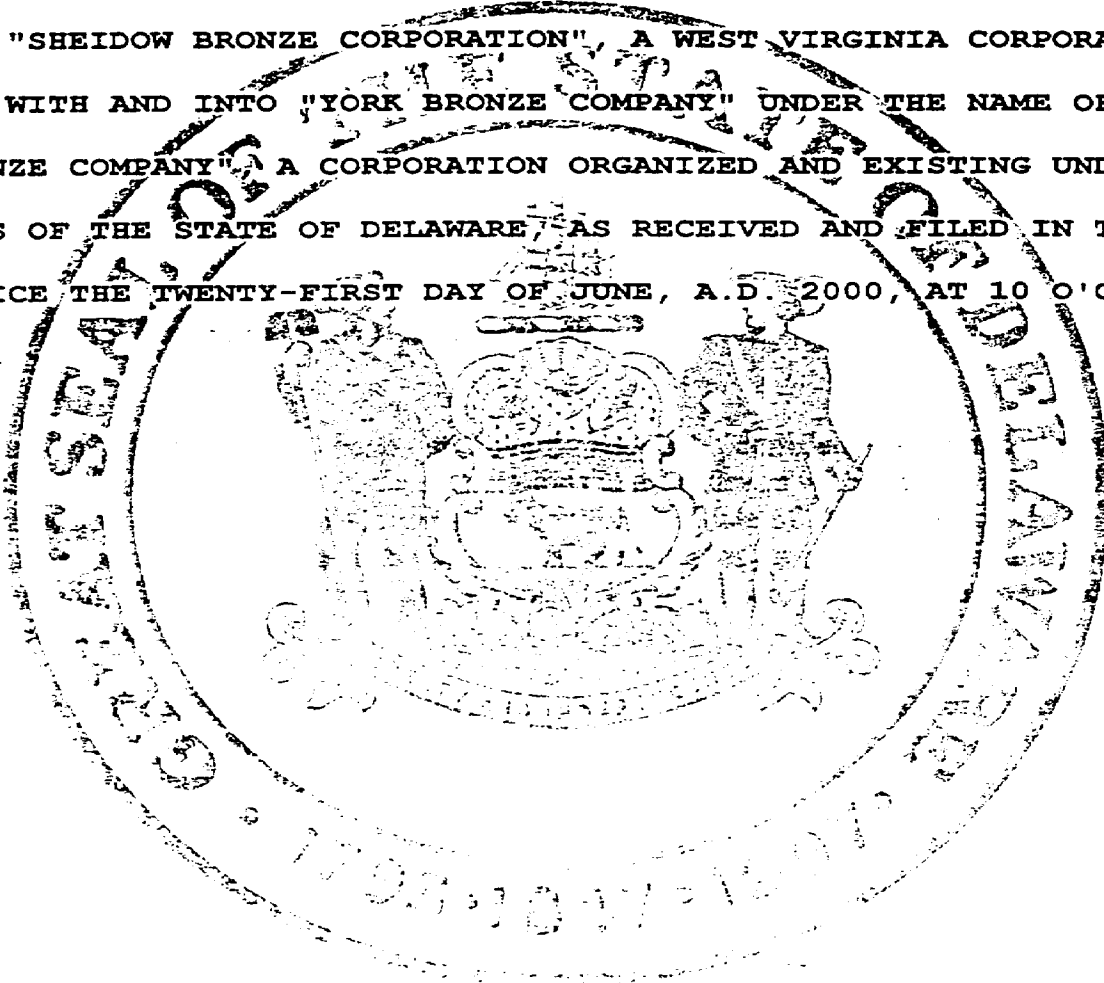

It is hereby certified that:

1. The constituent business corporations participating in the merger herein certified are:

(i) Sheidow Bronze Corporation, which is incorporated under the laws of the State of West Virginia; and

(ii) York Bronze Company, which is incorporated under the laws of the State of Delaware.

2. A Plan of Merger has been approved, adopted, certified, executed, and acknowledged by each of the aforesaid constituent corporations in accordance with the provisions of subsection (c) of Section 252 of the General Corporation Law of the State of Delaware, to wit, by Sheidow Bronze Corporation in accordance with the laws of the State of its incorporation and by York Bronze Company in the same manner as is provided in Section 251 of the General Corporation Law of the State of Delaware.

3.
