SECURITY AGREEMENT TERMINATION AND RELEASE

This Security Agreement Termination and Release (this "Termination") is made and entered into as of this 23rd day of May, 2000, by THE CIT GROUP/CREDIT FINANCE, INC. ("CIT"), for the benefit of GRANNY GOOSE FOODS, INC. ("Granny Goose").

R E C I T A L S

A. Pursuant to the terms of a security agreement between CIT and Granny Goose, a copy of which has been recorded with the U.S. Patent and Trademark Office on October 16, 1996, at Reel/Frame No. 1488/0923 (the "Security Agreement"), Granny Goose granted to CIT a security interest in its trademarks, including without limitation the trademark applications and registrations relating thereto (collectively, the "Trademarks").

B. CIT desires to terminate the Security Agreement and release its security interest in the Trademarks.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CIT hereby covenants and agrees as follows:

1. The Security Agreement, and CIT's security interest in the Trademarks, is hereby terminated and released.

2. CIT represents and warrants that it has the power and authority to execute this Termination.

3. CIT hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested and are required in order to more fully and effectively carry out the purposes of this Termination.
