And for said consideration, it is hereby covenanted and agreed that at the request and expense of Assignee, its successors and assigns, Assignor will execute any further papers and do such other acts and things as may be necessary and proper to permit Assignee, its successors and

assigns, to procure trademarks in the United States and in such foreign countries as Assignee, its successors and assigns may elect, and vest the full title thereto in Assignee, its successors and assigns.
