The following articles ("Articles of Incorporation") constitute the Amended and Restated Articles of Incorporation of R.A.M. Associates, Inc., a Colorado corporation (the "Corporation"). These Articles of Incorporation were adopted by the shareholders of the Corporation at a duly called meeting of the shareholders held on February 28, 2000 and, in compliance with the applicable provisions of the Colorado Business Corporation Act, Section 7-110-106(f), Colorado Revised Statutes, the Corporation hereby states that the number of votes cast for these Articles of Incorporation by each voting group entitled to vote separately on the amendment was sufficient for approval by that voting group. These Articles of Incorporation correctly set forth the provisions of the Corporation's articles of incorporation, as amended, and supersede the Corporation's original articles of incorporation and all amendments thereto.






