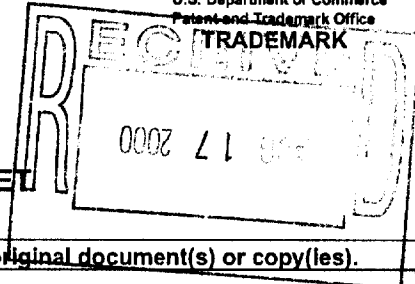

**CERTIFICATE OF AMENDMENT

CERTIFICATE OF INCORPORATION**

Scripps Howard Productions, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

**DOES HEREBY CERTIFY:**

**FIRST:** That the Board of Directors of said corporation, at a meeting duly held on December 7, 1998, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

**RESOLVED,** that the Certificate of Incorporation of Scripps Howard Productions, Inc. be amended by changing the First Article thereof so that, as amended, said Article shall be read as follows:
